Off-licence

Section 17 to 20, and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012 (the Act), Malolo Holdings Limited (the licensee) is authorised to sell alcohol on the premises situated at 3 Tainui Street Matamata and known as Super Liquor Matamata, to any person for consumption off the premises and to supply alcohol free, as a sample, for consumption on the premises.

If this licence is not endorsed under section 40 of the Act, the licensee is also authorised to sell alcohol on or from the premises and deliver it somewhere else.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

Conditions

This licence is subject to the following conditions:

- No alcohol is to be sold or delivered on Good Friday, Easter Sunday, Christmas Day, or before 1 pm on Anzac Day:
- Alcohol may be sold only on the following days and during the following hours: (b) Monday to Sunday from 7.00 am until 9.00 pm

- (c) The whole of the premises is designated as a supervised area
- (d) While alcohol is being provided free as a sample, drinking water is to be provided free from the same location
- The holder of a Manger's Certificate or a properly appointed manager shall be on duty and on the premises at all times alcohol is sold. If a duty manager is not present then there must be no alcohol sales and a notice displayed advertising the public of this fact
- Manager's register (as required by s.232 of the Act) is to be maintained and available onsite
- The licensee must ensure the following are displayed:
 - (i) A sign to be seen from outside the principle entrance stating the ordinary hours of business during which the premise will be open for the sale of alcohol
 - (ii) A copy of the original licence with all the conditions, just inside the principal entrance so persons entering can read it
 - (iii) A sign in a prominent place identifying the duty manager

Duration

Subject to the requirements of the Act relating to payment of fees, and to the provisions of the Act relating to suspension and cancellation of licences, this licence continues in force-

- until its expiry date detailed below; but
- if an application for the renewal of the licence is duly made before the licence would otherwise expire, until the close of the period of 3 years after the expiry date.
